

## **“NO FINE PRINT” LIFETIME WARRANTY**

The Window Source of Akron-Canton warrants to the original purchaser as well as to the immediate transferee (when applicable) of the **Model 3000, 6000 & 9000** series windows and patio doors the following:

**Duration of the Warranty-** This warranty shall stay in force for as long as the original purchaser owns the property that the windows are installed in as well as the immediate transferee (when applicable).

**Commercial Use-** This warranty applies in both owner occupied and non-owner occupied properties such as office buildings, rental properties, churches etc...

**Material and Workmanship-** Windows will be free from defects in material and workmanship.

**Vinyl Parts-** All made with non-regrind vinyl that under normal use will not crack, peel or corrode.

**Mechanical Parts and Screens-** Moving parts such as locking mechanisms, balances and screens are warranted against defects from manufacturing or improper installation.

**Seal Failure and Glass Breakage-** The sealed insulated glass unit is warranted against defects resulting in obstruction of vision caused by dust or moisture in the dead air space, as well as glass breakage caused by defects in manufacturing or improper installation.

The Window Source of Akron-Canton warrants to the original purchaser as well as to the immediate transferee (when applicable) of the **Model 6000 & 9000** series windows the following:

**Accidental Glass Breakage-** In the event of accidental glass breakage the property owner will be provided with a replacement glass unit at no charge.

**Transferability-** All of the above mentioned coverage shall apply to the original purchaser's immediate transferee when The Window Source of Akron-Canton is notified in writing within 30 days of the properties transfer date. The correspondence must include a \$40 transfer fee, address, phone number, and transferee name(s).

**Labor Warranty-** All labor for the original purchaser of a non-owner occupied property will be provided for a period of ten years by The Window Source of Akron-Canton. All labor for the original purchaser of an owner occupied property will be provided at no charge by The Window Source of Akron-Canton.

6. This warranty is exclusively for windows and patio doors. Any other products installed by The Window Source of Akron-Canton will carry a different warranty and/or the warranty provided by the manufacturer.
